Chair Carlton:

Today we will introduce 11 bill draft requests (BDRs) to keep things moving. Please keep in mind that a vote to introduce each bill is not a vote in support or opposition of that bill.

BDR S-1131 — Makes appropriations to the Department of Transportation for the replacement of the Nevada Shared Radio System. (Later introduced as [Assembly Bill 467](#).)

BDR S-1122 — Makes an appropriation to and authorizes the expenditure of money by the Division of Welfare and Supportive Services of the Department of Health and Human Services for the continuation of the technology modernization project for the child support enforcement program. (Later introduced as [Assembly Bill 474](#).)

BDR S-1055 — Makes a supplemental appropriation to the Department of Corrections for an unanticipated shortfall related to inmate-driven and food costs. (Later introduced as [Assembly Bill 473](#).)

BDR S-1135 — Makes appropriations to various divisions of the Department of Motor Vehicles for the replacement of computer hardware and software and certain other equipment. (Later introduced as [Assembly Bill 468](#).)

BDR S-1125 — Makes appropriations to the Department of Corrections for hepatitis C treatments for offenders and new and replacement medical and dental equipment. (Later introduced as [Assembly Bill 466](#).)

BDR 43-1088 — Authorizes the use of testing devices to determine the presence of a controlled substance or prohibited substance in the oral fluid of a person in certain circumstances. (Later introduced as [Assembly Bill 472](#).)

BDR S-1105 — Makes an appropriation to the Division of Water Resources of the State Department of Conservation and Natural Resources for the repair and maintenance of the South Fork Dam. (Later introduced as [Assembly Bill 465](#).)

BDR S-1147 — Makes a supplemental appropriation to the Real Estate Division of the Department of Business and Industry for a projected shortfall relating to time share filing fees. (Later introduced as [Assembly Bill 470](#).)

BDR S-1145 — Makes a supplemental appropriation to the Office of the Secretary of State for a projected shortfall related to credit card processing fees. (Later introduced as [Assembly Bill 469](#).)

BDR S-1051 — Makes appropriations to restore the balances in the State Claims Account, the Emergency Account, the Reserve for Statutory Contingency Account, and the Contingency Account. (Later introduced as [Assembly Bill 464](#).)

BDR 40-1082 — Revises provisions relating to the system for reporting information relating to cancer and other neoplasms. (Later introduced as [Assembly Bill 471](#).)
