BDR 40-1093: Revises provisions relating to environmental protection. (Later introduced as [Assembly Bill 452](#).)

BDR S-1112: Makes an appropriation to the Account for Pensions for Silicosis, Diseases Related to Asbestos and Other Disabilities. (Later introduced as [Assembly Bill 453](#).)

BDR S-1113: Makes an appropriation to the Nevada Promise Scholarship Account to support the Nevada Promise Scholarship Program. (Later introduced as [Assembly Bill 454](#).)

BDR S-1114: Makes an appropriation to the Office of the State Controller for the replacement of printers. (Later introduced as [Assembly Bill 455](#).)

BDR S-1120: Makes an appropriation to the Aging and Disability Services Division of the Department of Health and Human Services for pavement maintenance at the Jones campus of the Desert Regional Center. (Later introduced as [Assembly Bill 456](#).)

BDR S-1133: Makes an appropriation to the Division of Forestry of the State Department of Conservation and Natural Resources for deferred maintenance projects. (Later introduced as [Assembly Bill 457](#).)

BDR S-1134: Makes appropriations to the Real Estate Division of the Department of Business and Industry for an upgrade of its licensing software system and the replacement of computer hardware and software. (Later introduced as [Assembly Bill 458](#).)

BDR 18-1068: Revises provisions relating to workforce development. (Later introduced as [Assembly Bill 459](#).)
