SEAN SEVER (Administrator, Division of Management Services and Programs, Department of Motor Vehicles):

Assembly Bill 476 seeks to rename the Department of Motor Vehicles (DMV) Management Services and Programs Division to the Research and Project Management Division. This name change better reflects the main duties of this Division and the need for a formalized project management team as DMV prepares to transform its service delivery.

The Division consists of employees from budget accounts 4716 and 4742, joining two strong teams.

### SENATOR PICKARD:

The bill seems to be less than complex. Is the intent to align this with the current practice of the office; and it seems you answered this. The answer was yes. Do I have that right?

#### Mr. Sever:

Yes, that is correct. This is a simple name change for a division of DMV that better reflects its duties.
