SENATE BILL 58: Revises certain functions and responsibilities of the Investigation Division of the Department of Public Safety. (BDR 43-352)

SUSAN SCHOLLEY (Policy Analyst):

I will give an overview of <u>S.B. 58</u> from work session document (<u>Exhibit B</u>). <u>Senate Bill 58</u> was introduced on behalf of the Investigation Division of the Department of Public Safety (DPS) and referred to this Committee on February 10. This bill revises the responsibilities of the Investigation Division within the DPS to include investigations relating to technological crimes and assisting other divisions within the DPS. At the request of certain other departments who conduct criminal investigations regarding cannabis statutes, the Investigation Division would be authorized to assist them.

The Division would also be authorized to assist any board, agency, commission or a similar entity within the Executive Department that requests assistance and

is also authorized to conduct criminal investigations. There were no amendments and no testimony in opposition to this bill.
