A.B. 506	Makes appropriations to the Division of Enterprise Information Technology Services of the Department of Administration for the replacement of an information technology investments tracking system and computer hardware and associated software. (BDR S-1147)
A.B. 507	Makes appropriations to the Department of Corrections for a staffing study and the replacement or purchase of computer hardware and software and various types of equipment, vehicles and systems. (BDR S-1157)
A.B. 508	Makes appropriations to the Division of Parole and Probation of the Department of Public Safety for the replacement of computer hardware and associated software, radio equipment, certain weapons and an information technology system. (BDR S-1164)
