AN ACT making appropriations to the Division of Enterprise Information Technology Services of the Department of Administration for the replacement of an information technology investments tracking system and computer hardware and associated software; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. There is hereby appropriated from the State General Fund to the Division of Enterprise Information Technology Services of the Department of Administration the sum of \$246,000 for the Office of Chief Information Officer budget account for the replacement of the system for tracking information technology investments.

Sec. 2. There is hereby appropriated from the State General Fund to the Division of Enterprise Information Technology Services of the Department of Administration the sum of \$26,082 for the

Office of Chief Information Officer budget account for the replacement of computer hardware and associated software.

Sec. 3. Any remaining balance of the appropriations made by sections 1 and 2 of this act must not be committed for expenditure after June 30, 2025, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 19, 2025, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State General Fund on or before September 19, 2025.

Sec. 4. This act becomes effective upon passage and approval.
