SUMMARY—Revises provisions governing collective bargaining for local government employees. (BDR 23-700)

FISCAL NOTE: Effect on Local Government: May have Fiscal Impact.

AN ACT relating to collective bargaining; requiring each local government employer to semiannually provide each employee organization recognized by the local government employer certain information relating to each employee of the bargaining unit represented by the employee organization; and providing other matters properly relating thereto

Legislative Counsel's Digest:

Existing law requires each employee organization recognized by a local government employer in this State to file a report with the Government Employee-Management Relations Board each year containing certain information, including, without limitation, the total number of persons in each bargaining unit represented by the employee organization. (NRS 288.165) Section 1 of this bill requires, with certain exception, that each local government employer the provide each employee organization recognized by the local government employer the name, address, email address, telephone number, work contact information and work location of each employee in the bargaining unit represented by the employee organization at least on a semiannual basis. Section 1 further provides that if a local government employee notifies his or her employer in writing that he or she does not want the employee notifies his or her information to the employee organization, the local government employer: (1) must still provide the information to the employee organization more often; and (2) must still provide the information to the Government Employee-Management Relations Board when requested by order of the Board. Section 1 also provides that information about any local government employee provided to an employee organization or the Board is confidential and is not a public record.

Section 2 of this bill makes a conforming change to indicate the proper placement of section 1 in the Nevada Revised Statutes.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- **Section 1.** Chapter 288 of NRS is hereby amended by adding thereto a new section to read as follows:
- 1. [On] Except as otherwise provided in subsection 3, at least twice each year, on or before January 1 and July 1 . [fof each year,] each local government employer shall provide each employee organization recognized by the local government employer the name, address, email address, telephone number, work contact information and work location of each local government employee of the bargaining unit represented by the employee organization.
- 2. A local government employer is required to provide an employee organization with the information about a local government employee pursuant to subsection 1 regardless of whether the employee has joined the employee organization.
- 3. If a local government employee notifies his or her employer in writing that he or she does not want the employer to provide any of his or her information to the employee organization recognized by the local government employer, the local government employer:
- (a) Must still provide the information set forth in subsection 1 to the employee organization on or before January 1 and July 1 of each year but must not provide the information set forth in subsection 1 to the employee organization more often; and
- (b) Must still provide the information set forth in subsection 1 to the Government Employee-Management Relations Board when requested by the order of the Board.
- 4. Information about any local government employee that is provided pursuant to this section to an employee organization or the Government Employee-Management Relations Board is confidential and is not a public record.

Any such copies, abstracts or memoranda may be used to supply the general public with copies, abstracts or memoranda of the records or may be used in any other way to the advantage of the governmental entity or of the general public. This section does not supersede or in any manner affect the federal laws governing copyrights or enlarge, diminish or affect in any other manner the rights of a person in any written book or record which is copyrighted pursuant to federal law.

2. A governmental entity may not reject a book or record which is copyrighted solely because it is copyrighted.

- 3. A governmental entity that has legal custody or control of a public book or record shall not deny a request made pursuant to subsection 1 to inspect or copy or receive a copy of a public book or record on the basis that the requested public book or record contains information that is confidential if the governmental entity can redact, delete, conceal or separate, including, without limitation, electronically, the confidential information from the information included in the public book or record that is not otherwise confidential.
- 4. If requested, a governmental entity shall provide a copy of a public record in an electronic format by means of an electronic medium. Nothing in this subsection requires a governmental entity to provide a copy of a public record in an electronic format or by means of an electronic medium if:
 - (a) The public record:

- (1) Was not created or prepared in an electronic format; and
- (2) Is not available in an electronic format; or
- (b) Providing the public record in an electronic format or by means of an electronic medium would:
 - (1) Give access to proprietary software; or
- (2) Require the production of information that is confidential and that cannot be redacted, deleted, concealed or separated from information that is not otherwise confidential.
- 5. An officer, employee or agent of a governmental entity who has legal custody or control of a public record:
- (a) Shall not refuse to provide a copy of that public record in the medium that is requested because the officer, employee or agent has already prepared or would prefer to provide the copy in a different medium.
- (b) Except as otherwise provided in NRS 239.030, shall, upon request, prepare the copy of the public record and shall not require the person who has requested the copy to prepare the copy himself or herself.
