

SENATE BILL NO. 341—SENATORS CANNIZZARO, LANGE, DONDERO  
LOOP; DALY, DONATE, NEAL, OHRENSCHALL AND PAZINA

SUMMARY—Makes appropriations to the Food Bank of Northern Nevada and Three Square for the purpose of purchasing food for persons who are served by such organizations. (BDR S-502)

AN ACT making appropriations to the Food Bank of Northern Nevada and Three Square for the purpose of purchasing food for persons who are served by such organizations; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** 1. There is hereby appropriated from the State General Fund to the Food Bank of Northern Nevada for the purpose of purchasing food for distribution to persons served by the Food Bank the following sums:

For the Fiscal Year 2023-2024..... \$1,000,000

For the Fiscal Year 2024-2025..... \$1,000,000

2. Any balance of the sums appropriated by subsection 1 remaining at the end of the respective fiscal years must not be committed for expenditure after June 30 of the respective fiscal years by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 20, 2024, and September 19, 2025, respectively, by either the entity to which the money was appropriated or the entity



1 to which the money was subsequently granted or transferred, and  
2 must be reverted to the State General Fund on or before  
3 September 20, 2024, and September 19, 2025, respectively.

4 3. Upon acceptance of the money appropriated by subsection 1,  
5 the Food Bank of Northern Nevada agrees to:

6 (a) Prepare and transmit a report to the Interim Finance  
7 Committee on or before December 20, 2024, that describes each  
8 expenditure made from the money appropriated by subsection 1  
9 from the date on which the money was received by the Food Bank  
10 of Northern Nevada through December 1, 2024;

11 (b) Prepare and transmit a final report to the Interim Finance  
12 Committee on or before September 19, 2025, that describes each  
13 expenditure made from the money appropriated by subsection 1  
14 from the date on which the money was received by the Food Bank  
15 of Northern Nevada through June 30, 2025; and

16 (c) Upon request of the Legislative Commission, make available  
17 to the Legislative Auditor any of the books, accounts, claims,  
18 reports, vouchers or other records of information, confidential or  
19 otherwise, of the Food Bank of Northern Nevada, regardless of their  
20 form or location, that the Legislative Auditor deems necessary to  
21 conduct an audit of the use of the money appropriated pursuant to  
22 subsection 1.

23 **Sec. 2.** 1. There is hereby appropriated from the State  
24 General Fund to Three Square for the purpose of purchasing food  
25 for distribution to persons served by Three Square the following  
26 sums:

27 For the Fiscal Year 2023-2024..... \$1,000,000

28 For the Fiscal Year 2024-2025..... \$1,000,000

29 2. Any balance of the sums appropriated by subsection 1  
30 remaining at the end of the respective fiscal years must not be  
31 committed for expenditure after June 30 of the respective fiscal  
32 years by the entity to which the appropriation is made or any entity  
33 to which money from the appropriation is granted or otherwise  
34 transferred in any manner, and any portion of the appropriated  
35 money remaining must not be spent for any purpose after  
36 September 20, 2024, and September 19, 2025, respectively, by  
37 either the entity to which the money was appropriated or the entity  
38 to which the money was subsequently granted or transferred, and  
39 must be reverted to the State General Fund on or before  
40 September 20, 2024, and September 19, 2025, respectively.

41 3. Upon acceptance of the money appropriated by subsection 1,  
42 Three Square agrees to:

43 (a) Prepare and transmit a report to the Interim Finance  
44 Committee on or before December 20, 2024, that describes each  
45 expenditure made from the money appropriated by subsection 1



1 from the date on which the money was received by Three Square  
2 through December 1, 2024;

3 (b) Prepare and transmit a final report to the Interim Finance  
4 Committee on or before September 19, 2025, that describes each  
5 expenditure made from the money appropriated by subsection 1  
6 from the date on which the money was received by Three Square  
7 through June 30, 2025; and

8 (c) Upon request of the Legislative Commission, make available  
9 to the Legislative Auditor any of the books, accounts, claims,  
10 reports, vouchers or other records of information, confidential or  
11 otherwise, of Three Square, regardless of their form or location, that  
12 the Legislative Auditor deems necessary to conduct an audit of the  
13 use of the money appropriated pursuant to subsection 1.

14 **Sec. 3.** This act becomes effective on July 1, 2023.
