AN ACT relating to public employees; making appropriations for the implementation of certain collective bargaining agreements; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. 1. There is hereby appropriated from the State General Fund to the Office of Finance in the Office of the Governor the sum of \$9,812,804 for the costs of implementing the provisions of the collective bargaining agreement covering personnel represented by the bargaining units established in paragraphs (a), (e) and (f) of subsection 1 of NRS 288.515.

2. There is hereby appropriated from the State General Fund to the Office of Finance in the Office of the Governor the sum of \$8,586,982 for the costs of implementing the provisions of the collective bargaining agreement covering personnel represented by the bargaining unit established in paragraph (g) of subsection 1 of NRS 288.515.

3. There is hereby appropriated from the State General Fund to the Office of Finance in the Office of the Governor the sum of

5 4. There is hereby appropriated from the State General Fund to
6 the Office of Finance in the Office of the Governor the sum of
7 \$41,885,983 for the costs of implementing the provisions of the
8 collective bargaining agreement covering personnel represented by
9 the bargaining unit established in paragraph (i) of subsection 1 of
10 NRS 288.515. Expenditure of \$5,275,000 not appropriated from the
11 State General Fund or State Highway Fund is hereby authorized
12 during Fiscal Year 2023-2024 and Fiscal Year 2024-2025 by the
13 Office of Finance in the Office of the Governor for the same
14 purpose.

15 5. There is hereby appropriated from the State General Fund to
16 the Office of Finance in the Office of the Governor the sum of
17 \$387,488 for the costs of implementing the provisions of the
18 collective bargaining agreement covering personnel represented by
19 the bargaining unit established in paragraph (k) of subsection 1 of
20 NRS 288.515.

21 6. Any remaining balance of the appropriations made by this
22 section must not be committed for expenditure after June 30, 2025,
23 by the entity to which the appropriation is made or any entity to
24 which money from the appropriation is granted or otherwise
25 transferred in any manner, and any portion of the appropriated
26 money remaining must not be spent for any purpose after
27 September 19, 2025, by either the entity to which the money was
28 appropriated or the entity to which the money was subsequently
29 granted or transferred, and must be reverted to the State General
30 Fund on or before September 19, 2025.

31 **Sec. 2.** This act becomes effective on July 1, 2023.
