INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen La Rue Hatch, Summers-Armstrong, Anderson, Watts, González, Considine and Orentlicher:

Assembly Bill No. 144—AN ACT relating to lighting products; prohibiting the sale, offer to sell or distribution of compact fluorescent lamps and linear fluorescent lamps; authorizing the Director of the Office of Energy within the Office of the Governor to take certain actions to investigate possible violations; authorizing the Director or his or her designee to conduct certain inspections; authorizing the Director to adopt certain regulations; providing a civil penalty; and providing other matters properly relating thereto.

Assemblyman Watts moved that the bill be referred to the Committee on Growth and Infrastructure.

Motion carried.

By Assemblywoman Marzola:

Assembly Bill No. 145—AN ACT relating to crimes; increasing the penalties for a customer who unlawfully engages in prostitution or solicitation therefor; removing a duplicative provision in existing law relating to prostitution; and providing other matters properly relating thereto.

Assemblywoman Brittney Miller moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblywoman Marzola:

Assembly Bill No. 146—AN ACT relating to information technology; revising the definition of the term “video service”; and providing other matters properly relating thereto.

Assemblywoman Marzola moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblywoman Marzola:

Assembly Bill No. 147—AN ACT relating to dentistry; requiring dental hygienists and dental therapists to comply with certain requirements governing the provision of health care; requiring certain providers of dental care to receive training on teledentistry; prescribing certain requirements relating to the secure storage of electronic records; providing for the issuance of special endorsements for a dentist, dental hygienist or dental therapist to administer immunizations; imposing certain requirements relating to the administration of immunizations by the holder of such an endorsement; deeming certain conduct by a provider of dental care to be unprofessional conduct; authorizing the imposition of disciplinary action against a dentist, dental hygienist or dental therapist for certain violations; requiring hospitals and issuers of Medicaid managed care plans to take certain measures to ensure access by recipients of Medicaid to teledentistry; requiring a public or private school or child care facility to accept a dental examination, screening or assessment provided through teledentistry for certain purposes; imposing certain requirements relating to the provision of services through teledentistry; providing a penalty; and providing other matters properly relating thereto.

Assemblywoman Marzola moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblywoman Marzola:

Assembly Bill No. 148—AN ACT relating to child welfare; prescribing qualifications for magistrates who make certain determinations concerning child custody; providing for the appointment of a guardian ad litem for an incapacitated parent or other person responsible for the welfare of a child in certain child welfare proceedings; revising the titles of certain officials appointed to oversee proceedings concerning juveniles and child support; prescribing the procedure for the judicial review of the placement of a child who is in the custody of an agency which provides child welfare services in a qualified residential treatment program; revising the procedures governing the court-ordered admission of such a child who has an emotional disturbance to certain psychiatric facilities and the release of such a child from such a facility; and providing other matters properly relating thereto.

Assemblywoman Brittney Miller moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblywomen Brittney Miller and Anderson:

Assembly Bill No. 149—AN ACT relating to education; creating the Office of the Inspector General of Education and the position of Inspector General of

Education; setting forth the powers and duties of the Inspector General and employees of the Office; requiring certain persons and governmental entities to cooperate with and provide assistance to the Inspector General in carrying out those duties; prohibiting retaliation against certain persons who make a lawful complaint concerning fraud, waste, abuse or corruption within a person or governmental entity that receives public money related to education; prohibiting certain acts to deter or prevent the Inspector General or an employee of the Office from performing his or her duty; imposing increased penalties for certain acts of assault or battery on the Inspector General or an employee of the Office; providing penalties; and providing other matters properly relating thereto.

Assemblywoman Bilbray-Axelrod moved that the bill be referred to the Committee on Education.

Motion carried.

By Assemblywomen Anderson, Considine, Backus, Taylor, Cohen, La Rue Hatch, Summers-Armstrong and Thomas:

Assembly Bill No. 150—AN ACT relating to education; revising provisions requiring the Board of Regents of the University of Nevada to grant certain waivers of fees for certain students who are Native American; and providing other matters properly relating thereto.

Assemblywoman Bilbray-Axelrod moved that the bill be referred to the Committee on Education.

Motion carried.

By Assemblymen Anderson, Yeager, Torres, Taylor, O'Neill, Cohen, Marzola and McArthur; Senators Cannizzaro, Titus, SeEVERS Gansert and Daly:

Assembly Bill No. 151—AN ACT relating to special license plates; providing for the issuance of special license plates commemorating the 150th anniversary of the founding of the University of Nevada, Reno; exempting the special license plates from certain provisions otherwise applicable to special license plates; and providing other matters properly relating thereto.

Assemblyman Watts moved that the bill be referred to the Committee on Growth and Infrastructure.

Motion carried.

By the Committee on Ways and Means:

Assembly Bill No. 152—AN ACT making an appropriation to restore the balance in the Reserve for Statutory Contingency Account; and providing other matters properly relating thereto.

Assemblywoman Monroe-Moreno moved that the bill be referred to the Committee on Ways and Means.

Motion carried.

By Assemblywoman Marzola:

Assembly Bill No. 153—AN ACT relating to naprapathy; requiring naprapaths to comply with certain requirements; establishing the Naprapathic Practice Advisory Board; providing for the regulation of the practice of naprapathy by the State Board of Osteopathic Medicine; prohibiting the unlicensed practice of naprapathy except in certain circumstances; prescribing the requirements for the issuance and renewal of a license to practice naprapathy; providing for the collection of certain information; prescribing certain requirements governing the practice of naprapathy; authorizing the State Board of Osteopathic Medicine to take certain actions to investigate and impose discipline against a naprapath; prescribing certain duties and authority of a naprapath; establishing a privilege for certain confidential communications; providing penalties; and providing other matters properly relating thereto.

Assemblywoman Marzola moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblymen Peters, Orentlicher, Anderson, Cohen and Considine and Senator Krasner:

Assembly Bill No. 154—AN ACT relating to tissue donation; requiring the State Board of Health to regulate the living donation of birth tissue; requiring an organization that processes birth tissue to be certified; providing a penalty; and providing other matters properly relating thereto.

Assemblywoman Peters moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Assemblymen Peters and Orentlicher:

Assembly Bill No. 155—AN ACT relating to health care; establishing the Task Force on Precision Medicine and Biomarker Testing; prescribing the membership and duties of the Task Force; establishing March as Precision Medicine and Biomarker Testing Awareness Month; requiring policies of health insurance to include coverage of biomarker testing in certain circumstances; establishing certain conditions relating to such required coverage; making an appropriation; providing for a study of certain matters relating to precision medicine and biomarker testing; and providing other matters properly relating thereto.

Assemblywoman Peters moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By the Committee on Health and Human Services:

Assembly Bill No. 156—AN ACT relating to substance use disorders; establishing the order in which a provider or program is required to prioritize persons for participation in certain publicly funded programs for the treatment

of alcohol or other substance use disorders; prescribing certain requirements to ensure the access of offenders or prisoners who have been diagnosed with an opioid use disorder to medication-assisted treatment and the continuation of such treatment upon the release or transfer of such offenders or prisoners; prohibiting certain discrimination regarding such treatment; prescribing certain requirements concerning the diagnosis and treatment of a patient with an opioid use disorder; and providing other matters properly relating thereto.

Assemblywoman Peters moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Assemblywomen Taylor, Anderson, Considine and González and Senator Spearman:

Assembly Bill No. 157—AN ACT relating to sex trafficking; revising the penalties for the crime of living from the earnings of a prostitute; providing a penalty; and providing other matters properly relating thereto.

Assemblywoman Brittney Miller moved that the bill be referred to the Committee on Judiciary.

Motion carried.
