#### ASSEMBLYMAN MCARTHUR:

**Error! No document variable supplied.**urges the United States Department of Veterans Affairs to study the effectiveness and use of hyperbaric oxygen therapy for veterans and share the results with the state of Nevada.

ASSEMBLYWOMAN BILBRAY-AXELROD:

I was wondering if the Assemblyman could explain hyperbaric oxygen therapy.

#### ASSEMBLYMAN MCARTHUR:

Hyperbaric oxygen therapy is basically putting a lot of oxygen into your system. You basically have to have a mask so that you can stay pressurized. It pushes the oxygen at a pressure about three times your normal amount. It helps out the blood and your flexibility. You actually have to have about 20 sessions before it really has an effect.

## ASSEMBLYMAN O'NEILL:

In support of our Assemblyman's resolution and to give additional information, there is preliminary information indicating that the therapy assists greatly with both PTSD [post-traumatic stress disorder] treatments and burn treatments—scars. Some of you may be familiar with Jay Leno. He suffered a serious burn while working on a Stanley Steamer vehicle several weeks ago. He was in and out of the hospital within three days, mainly because he received HBOT [hyperbaric oxygen therapy] treatment, at his own expense, during that time. It has proven worthy. I will ask all my membership in this body to vote in favor of it.

Assembly Bill No. 312—AN ACT relating to environmental justice; creating the Commission on Environmental Justice; setting forth certain duties of the Commission; establishing various requirements for agencies to determine the environmental impact of a proposed regulation on historically underserved communities; and providing other matters properly relating thereto.

Assemblywoman Torres moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 313—AN ACT relating to mining; requiring an operator of a mining operation to submit a revised plan for reclamation under certain circumstances; revising provisions relating to the reclamation of exploration projects and mining operations; revising requirements relating to a plan for reclamation; providing a penalty; and providing other matters properly relating thereto.

Assemblywoman Cohen moved that the bill be referred to the Committee on Natural Resources.

Assembly Bill No. 315—AN ACT relating to energy; requiring the Director of the Office of Energy to coordinate with certain entities to recommend best practices for issuing a permit for geothermal energy; temporarily creating the Geothermal Energy Systems Demonstration Program; prohibiting certain restrictions on the use of a system for obtaining geothermal energy by the owners of real property; requiring the Office of Energy to conduct an interim study relating to geothermal energy; and providing other matters properly relating thereto.

Assembly Bill No. 318—AN ACT relating to medicine; revising certain procedures relating to the expiration of a license to practice medicine; requiring a physician assistant, practitioner of respiratory care or perfusionist or the insurer of such a person to report certain information relating to an action or claim of malpractice to the Board of Medical Examiners; providing administrative penalties; requiring the Board to investigate a physician assistant, practitioner of respiratory care or perfusionist in certain

circumstances; authorizing the Board to examine such a person under certain circumstances; and providing other matters properly relating thereto.

Assemblywoman Marzola moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 319—AN ACT making an appropriation to the Department of Education for the purpose of awarding grants of money to Nevada school districts to provide universal free breakfast and lunch for Nevada pupils; and providing other matters properly relating thereto.

Assembly Bill No. 320—AN ACT relating to Internet privacy; imposing certain requirements on certain businesses that provide an online service, product or feature that is likely to be accessed by children; exempting certain information and entities from those requirements; providing a civil penalty for violations of those requirements; requiring the Attorney General to take certain actions before bringing a civil action against a business to recover such a civil penalty under certain circumstances; and providing other matters properly relating thereto.

Assemblywoman Marzola moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 321—AN ACT relating to public safety; setting forth certain requirements and restrictions concerning foil balloons that are sold, offered for sale or manufactured in this State; prohibiting, with certain exceptions, a person from selling, offering for sale or manufacturing a foil balloon that fails to meet certain requirements; requiring the Public Utilities Commission of Nevada to adopt a standard for the testing and evaluation of the dielectric performance of foil balloons; prohibiting a person from committing certain acts against the infrastructure of a public utility; providing penalties; and providing other matters properly relating thereto.

Assemblywoman Marzola moved that the bill be referred to the Committee on Commerce and Labor.

By Assemblymen Nguyen, Yeager, González, Brown-May, Dickman, D'Silva and Gallant; Senators Hansen and Nguyen:

Assembly Bill No. 322—AN ACT relating to public health; prohibiting a person from preparing, distributing, advertising, selling or offering to sell a kratom product unless the kratom product has been registered with the State Board of Oriental Medicine; setting forth requirements for the registration of a kratom product with the Board; authorizing the Board to take certain actions relating to kratom products offered for sale that are not registered with the Board; authorizing the Board to adopt certain regulations governing kratom products; revising provisions establishing certain prohibited acts relating to kratom products; providing penalties; and providing other matters properly relating thereto.

Assemblywoman Marzola moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 323—AN ACT relating to education; requiring the Superintendent of Public Instruction to develop a strategic plan for the recruitment of teachers and other licensed educational personnel; requiring the Commission on Professional Standards in Education to adopt certain regulations concerning the licensing of teachers and other educational personnel; authorizing a school district to compensate a student who is assigned for training purposes as a student teacher, counselor or trainee in a library; authorizing a school district or the governing body of a charter school to provide certain professional development training; creating the Incentivizing Pathways to Teaching Account in the State General Fund; establishing the Incentivizing Pathways to Teaching Program; and providing other matters properly relating thereto.

ASSEMBLYWOMAN CONSIDINE:

Assembly Bill 76 increases the maximum amount of costs that a court may award to a prevailing party for the reasonable fees of expert witnesses, from \$1,500 for each expert witness to not more than \$15,000 for each expert witness.

Remarks by Assemblywoman Monroe-Moreno.

ASSEMBLYWOMAN MONROE-MORENO:

Assembly Bill 268, as amended, makes General Fund appropriations for the payment of retention incentives of \$500 to employees of state government employed on March 31, 2023, and June 16, 2023, as follows: \$20,970,000 to the Governor's Office of Finance for employees of the Executive and Judicial Departments of state government, except for persons whose positions are temporary, intermittent, or seasonal or persons who fill positions for which there is a critical labor shortage; professional staff of the Nevada System of Higher Education; and persons whose compensation is paid from a budget account that is not subject to NRS [Nevada Revised Statutes] 353.150 to 353.246, inclusive, unless otherwise provided.

It also provides for \$325,000 to the Legislative Fund for employees of the Legislative Department of state government, except persons whose positions are for a legislative session or are otherwise temporary, intermittent, or seasonal.

An additional \$81,000 is provided for the Public Employees' Retirement System for employees of PERS [Public Employees' Retirement System], except persons whose positions are temporary, intermittent, or seasonal or persons who fill positions for which there is a critical labor shortage.

This act becomes effective upon passage and approval.
