#### INTRODUCTION, FIRST READING AND REFERENCE

By Senators Hansen, Buck, Titus, Goicoechea, Krasner and Stone:

Senate Bill No. 157—AN ACT relating to elections; eliminating the authority of a person to register to vote or update his or her voter registration information after the close of registration; and providing other matters properly relating thereto.

Senator Hansen moved that the bill be referred to the Committee on Legislative Operations and Elections.

Motion carried.

By Senator Hammond:

Senate Bill No. 158—AN ACT relating to education; requiring public schools to install video cameras in certain classrooms used for special education; prescribing the length of time that a recording from such a video camera must be retained; specifying the circumstances under which such a recording may be released; and providing other matters properly relating thereto.

Senator Hammond moved that the bill be referred to the Committee on Education.

Motion carried.

By Senator Hammond:

Senate Bill No. 159—AN ACT relating to pest control; establishing provisions governing the issuance of a provisional license as an applicator to engage in pest control; requiring the Director of the State Department of Agriculture to establish a fee for the issuance of such a provisional license; providing a penalty; and providing other matters properly relating thereto.

Senator Hammond moved that the bill be referred to the Committee on Natural Resources.

By Senator Hammond:

Senate Bill No. 160—AN ACT relating to professions; exempting certain persons from provisions of existing law governing certified court reporters and court reporting firms; providing for the certification and regulation of certified legal video recorders and the licensure and regulation of legal video recording firms by the Certified Court Reporters' Board of Nevada; defining certain terms and revising certain definitions relating to certified court reporters, court reporting firms, certified legal video recorders and legal video recording firms; revising the membership of the Board; revising certain requirements for the certification and licensure of certified court reporters and court reporting firms; imposing and revising certain fees applicable to certified court reporters, court reporting firms, certified legal video recorders and legal video recording firms; authorizing the Board to refer certain violations involving a person who engages in certain activities without a certificate or license to a district attorney or the Attorney General; requiring the district attorney of a county or the Attorney General to prosecute such violations; and providing other matters properly relating thereto.

Senator Hammond moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Senators Scheible, Harris, Spearman, Cannizzaro, Seevers Gansert, Daly, Doñate, Dondero Loop, Flores, Goicoechea, Hansen, Krasner, Neal, Nguyen, Ohrenschall, Pazina and Stone:

Senate Bill No. 161—AN ACT relating to public assistance; providing for the use of benefits under certain federal programs for persons with low incomes to purchase menstrual products; and providing other matters properly relating thereto.

Senator Scheible moved that the bill be referred to the Committee on Health and Human Services.

By Senator Scheible:

Senate Bill No. 162—AN ACT relating to elections; providing for the establishment of polling places in county and city jails; and providing other matters properly relating thereto.

By Senators Scheible, Harris and Spearman and Assemblywoman González:

Senate Bill No. 163—AN ACT relating to insurance; requiring certain health insurance to include coverage for the treatment of conditions relating to gender dysphoria, gender incongruence and other disorders of sexual development; and providing other matters properly relating thereto.

Senator Scheible moved that the bill be referred to the Committee on Commerce and Labor.

GENERAL FILE AND THIRD READING

Senate Bill No. 124.

Bill read third time.

Remarks by Senators Cannizzaro, Seevers Gansert, Titus and Goicoechea.

SENATOR CANNIZZARO:

Senate Bill No. 124, as amended, revises and clarifies existing provisions pertaining to the money received by county school districts from the tax upon the net proceeds of minerals and royalties of mining operations and the requirement to transfer such money to the State Education Fund. The bill also advances, to June 30, 2022, from June 30, 2023, the expiration of the requirement that entities make advance payment of the portion of the tax upon net proceeds of minerals and royalties of mining operations owed to the State General Fund based upon estimates for that current calendar year.

I urge my colleagues to support this piece of legislation. It does allow us to have more fiscal responsibility in our budgeting. It allows us to absorb that prepayment ending early and avoid a lack of funds that should be going to our State Education Fund later in the biennium.

SENATOR SEEVERS GANSERT:

I oppose Senate Bill No. 124. This bill was brought forward last week, and whenever you change the budget, it dominoes. It changes any fund balances for this year and next year. It shifts the money because the Pupil-Centered Funding Plan is revenue-driven. Normally what would happen is the Governor would have an opportunity to provide a budget amendment to offer a proposition on how that money should be spent. There is a lot of uncertainty around how this could domino through the budget, and we have not had enough time to examine it.

With that said, this may be something we can support in the future. Today, we do not have information on how it changes any education balances, the Rainy Day Fund, the Education Stabilization Account, et cetera. All these things are uncertain. We need to examine this more closely.

SENATOR TITUS:

I oppose Senate Bill No. 124. My concerns revolve around the potential impacts on the rural counties that may have already budgeted for these funds. They may no longer have them available. If anything, it is premature.

SENATOR GOICOECHEA:

I oppose Senate Bill No. 124. Clearly, it removes being able to apply the Assessors' Technology Fund to the net proceeds. They continue to have to do the work. While I agree the commission that goes to the Treasurer might well be removed, the net proceeds still fall to local counties even though they are centrally assessed. I have local governments that have budgeted for this and will no longer have that piece, however small, of the Assessors' Technology Fund available to them. I urge you to vote "no."
