By Senators Spearman, Doñate, Dondero Loop, Harris, Krasner, Neal, Nguyen, Pazina and Scheible and Assemblyman D'Silva:

Senate Bill No. 164—AN ACT relating to special license plates; revising provisions governing the distribution of fees collected for the issuance or renewal of special license plates indicating support for the Divine Nine; and providing other matters properly relating thereto.

Senator Spearman moved that the bill be referred to the Committee on Growth and Infrastructure.

Motion carried.

By Senators Spearman, Krasner, Doñate, Lange and Nguyen:

Senate Bill No. 165—AN ACT relating to technology; creating the Emerging Technologies Task Force within the Department of Business and Industry; prescribing the membership, powers and duties of the Task Force; authorizing the Director of the Department to create an Opportunity Center for Emerging Technology Businesses as part of the Office of Business Finance and Planning of the Department; and providing other matters properly relating thereto.

Senator Spearman moved that the bill be referred to the Committee on Government Affairs.

By Senators Pazina, Daly, Dondero Loop and Nguyen; Assemblymen Hibbetts and Yurek:

Senate Bill No. 166—AN ACT relating to collective bargaining; revising the definition of "supervisory employee" for the purposes of collective bargaining for local government and state employees; revising the provisions relating to bargaining units of state employees who are peace officers or supervisory employees; and providing other matters properly relating thereto.

Senator Pazina moved that the bill be referred to the Committee on Government Affairs.

Senate Bill No. 167—AN ACT relating to insurance; prohibiting the imposition of a step therapy protocol for a drug prescribed to treat a psychiatric condition under certain circumstances; and providing other matters properly relating thereto.

Senator Dondero Loop moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By the Committee on Government Affairs:

Senate Bill No. 168—AN ACT relating to emergency management; authorizing the Division of Emergency Management in the Office of the Military to use money in the Emergency Assistance Account for the purpose of emergency management; requiring the Department of Employment, Training and Rehabilitation to conduct a study during the 2023-2024 legislative interim concerning the unemployment system in this State and the

impact of a crisis on employment; and providing other matters properly relating thereto.

Senator Flores moved that the bill be referred to the Committee on Government Affairs.

By the Committee on Government Affairs:

Senate Bill No. 169—AN ACT relating to land use planning; requiring certain local governments to include a heat mitigation element in master plans; and providing other matters properly relating thereto.

Senator Flores moved that the bill be referred to the Committee on Government Affairs.

By Senators Stone, Krasner, Hansen, Buck, Titus, Goicoechea and Seevers Gansert; Assemblymen Yurek, Dickman, Kasama, Gray, Gallant, Hansen and Koenig:

Senate Bill No. 170—AN ACT relating to crimes; revising various provisions governing the penalties for sex trafficking and facilitating sex trafficking; providing for the admissibility of certain evidence relating to the character of the defendant in a prosecution for an offense involving domestic violence; providing penalties; and providing other matters properly relating thereto.

Senator Stone moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Senators Harris, Spearman, Doñate, Flores, Ohrenschall and Scheible:

Senate Bill No. 171—AN ACT relating to crimes; prohibiting the purchase, possession or ownership of a firearm by a person who has been convicted of committing or attempting to commit a crime motivated by certain characteristics of the victim; and providing other matters properly relating thereto.

Senator Harris moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Senators Harris, Scheible, Doñate, Ohrenschall and Pazina:

Senate Bill No. 172—AN ACT relating to health care; authorizing a minor to give express consent to certain health care providers for certain services for the prevention of sexually transmitted diseases and pregnancy; and providing other matters properly relating thereto.

Senator Harris moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Senators Buck and Krasner and Assemblywoman Marzola:

Senate Bill No. 173—AN ACT relating to evidence; revising provisions relating to statements or confessions made in certain criminal actions; and providing other matters properly relating thereto.

Senator Buck moved that the bill be referred to the Committee on Judiciary.

By Senators Hammond, Neal, Goicoechea and Ohrenschall and Assemblyman Gurr:

Senate Bill No. 174—AN ACT relating to common-interest communities; revising provisions relating to the exemption from licensure as a collection agency for community managers of common-interest communities; and providing other matters properly relating thereto.

Senator Hammond moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Senator Spearman; Assemblymen Thomas, D'Silva, Brown-May, Gray and O'Neill:

Senate Bill No. 175—AN ACT relating to common-interest communities; revising requirements for the foreclosure of a lien against a unit in a common-interest community owned by a person who is or who has a household member who is a veteran, a senior citizen or a person with a disability; revising requirements for the repair of certain areas within a common-interest community; revising provisions relating to the termination of a common-interest community; revising the information that is required to be provided to a purchaser of a unit in a common-interest community; authorizing certain damages to be awarded against unit-owners' associations in certain civil actions; requiring the adoption of certain regulations concerning the suspension or revocation of certificates for certain community managers; imposing certain requirements on a collection agency relating to the collection of a debt on behalf of a unit-owners' association; providing penalties; and providing other matters properly relating thereto.

Senator Spearman moved that the bill be referred to the Committee on Judiciary.

Motion carried.
