**INTRODUCTION, FIRST READING AND REFERENCE**

By Senator Harris:

Senate Bill No. 223—AN ACT relating to real property; revising certain requirements for the recording of a notice of pendency of an action affecting real property; revising provisions relating to landlords and tenants; revising certain requirements for the sale of real property pursuant to the power of sale under a deed of trust; revising certain definitions; revising requirements for the recording of certain instruments; clarifying the circumstances under which certain claims of a real estate broker are satisfied; and providing other matters properly relating thereto.

Senator Harris moved that the bill be referred to the Committee on Judiciary.  
Motion carried.

By Senators Goicoechea, Hansen, Stone, Titus and Hammond and Assemblyman Gurr:

Senate Bill No. 224—AN ACT relating to wildlife; revising the membership of the Board of Wildlife Commissioners; and providing other matters properly relating thereto.

Senator Goicoechea moved that the bill be referred to the Committee on Natural Resources.

Motion carried.

By Senator Harris:

Senate Bill No. 225—AN ACT relating to peace officers; revising provisions relating to the required contents of an application for certification as a peace officer; requiring a law enforcement agency to provide to the Peace Officers' Standards and Training Commission certain notice and information concerning peace officers employed by the agency; prohibiting a law enforcement agency from requiring a peace officer to make certain attestations concerning cannabis as a condition precedent to employment; prescribing requirements for certain standards adopted by regulation of the Commission; disqualifying certain persons from serving as peace officers; requiring the Executive Director of the Commission to report certain information to the National Decertification Index of the International Association of Directors of Law Enforcement Standards and Training or an equivalent database; and providing other matters properly relating thereto.

Senator Harris moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Senator Cannizzaro and Assemblyman Yeager:

Senate Bill No. 226—AN ACT relating to public works; providing a declaration of legislative intent regarding the payment of prevailing wages on public works projects; deeming certain projects to be financed in whole or in part from public money for purposes of determining whether a project is a public work; excluding certain public works projects from certain procedures for awarding contracts; revising certain definitions relating to public works; requiring the payment of prevailing wages to workers who perform custom fabrication on a public work or for certain performance contracts of local governments or state agencies; and providing other matters properly relating thereto.

Senator Cannizzaro moved that the bill be referred to the Committee on Government Affairs.

Motion carried.
