#### INTRODUCTION, FIRST READING AND REFERENCE

By Senator Nguyen:

Senate Bill No. 280—AN ACT relating to health care; requiring a hospital to provide for the insertion of certain intrauterine contraceptive devices if requested by a patient giving birth at a hospital; prohibiting an insurer from refusing to cover the insertion of certain intrauterine contraceptive devices at a hospital immediately after an insured gives birth; and providing other matters properly relating thereto.

Senator Nguyen moved that the bill be referred to the Committee on Health and Human Services.

# By Senator Nguyen:

Senate Bill No. 281—AN ACT relating to natural gas; requiring certain natural gas utilities to file with the Public Utilities Commission of Nevada a triennial plan designed to meet the current and future demand for natural gas at the lowest reasonable cost to the natural gas utility and its customers; prohibiting a natural gas utility from filing a general rate application under certain circumstances; revising provisions governing certain regulations the

Commission is required to adopt with respect to natural gas utilities; and providing other matters properly relating thereto.

Senator Nguyen moved that the bill be referred to the Committee on Growth and Infrastructure.

Senate Bill No. 282—AN ACT relating to education; clarifying that the hiring of staff by a principal of a local school precinct must conform to applicable collective bargaining agreements; requiring certain approval from an organizational team of a local school precinct to approve a plan of operation for the local school precinct; making the principal of a local school precinct a voting member of the organizational team; revising the procedure for the selection of a candidate to fill a vacancy in the position of principal of a local school precinct; and providing other matters properly relating thereto.

Senator Nguyen moved that the bill be referred to the Committee on Education.

Senate Bill No. 283—AN ACT relating to health care; requiring certain persons and entities to furnish health care records electronically under certain circumstances; prohibiting such persons and entities from charging a fee to furnish health care records electronically if the health care records are maintained electronically; and providing other matters properly relating thereto.

Senator Pazina moved that the bill be referred to the Committee on Commerce and Labor.

Senate Bill No. 284—AN ACT relating to offenders; revising provisions relating to the assignment of certain offenders to an institution or facility of minimum security; and providing other matters properly relating thereto.

Senate Bill No. 289—AN ACT relating to crimes; expanding the applicability of enhanced penalties for assault or battery against a provider of health care under certain circumstances; creating a rebuttable presumption that a person knows or should have known that another person was a provider of

health care under certain circumstances; providing penalties; and providing other matters properly relating thereto.

Senator Nguyen moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Senators Cannizzaro and Lange:

Senate Bill No. 290—AN ACT relating to financial services; requiring a person who provides employer-integrated earned wage access services to obtain a license from the Commissioner of Financial Institutions; imposing certain requirements on such licensees; and providing other matters properly relating thereto.

Senator Cannizzaro moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Senators Cannizzaro, Dondero Loop, Lange, Flores, Neal, Daly, Doñate, Harris, Nguyen, Ohrenschall, Pazina, Scheible and Spearman:

Senate Bill No. 291—AN ACT relating to education; revising requirements for certain student teachers to be employed as a substitute teacher for a school district; making an appropriation to the Department of Education for the Nevada Institute on Teaching and Educator Preparation; and providing other matters properly relating thereto.

Senator Cannizzaro moved that the bill be referred to the Committee on Education.

Motion carried.

By Senator Pazina:

Senate Bill No. 292—AN ACT relating to education; providing that certain principals are employed at will; requiring certain postprobationary school administrators to apply for reappointment to their administrative positions; and providing other matters properly relating thereto.

Senator Pazina moved that the bill be referred to the Committee on Education.

Motion carried.

By Senators Doñate and Daly:

Senate Bill No. 293—AN ACT relating to energy; revising provisions governing the conservation of energy in certain buildings; requiring an electric utility to file a plan to increase access to renewable energy systems by residential electric customers; repealing limitations on the use of electric resistance for heating spaces; and providing other matters properly relating thereto.

Senator Doñate moved that the bill be referred to the Committee on Growth and Infrastructure.

Motion carried.

By Senators Doñate, Flores, Harris and Scheible:

Senate Bill No. 294—AN ACT relating to firearms; creating the crime of unsafe storage of a firearm; requiring a licensed dealer to provide a locking device capable of securing a firearm with each sale or transfer of a firearm; requiring a licensed gun dealer to post a notice on the premises which informs a buyer that the unlawful storage of a firearm may result in imprisonment or a fine; requiring the board of trustees of each school district and the governing body of each charter school to provide active shooter preparedness training to each employee; requiring the Department of Education to include in a model plan for management of a suicide, crisis or emergency a procedure for providing drills to instruct pupils in the appropriate procedures to be followed in response to an active shooter emergency; requiring the Department of Health and Human Services to develop and implement a safe firearm storage education campaign; providing penalties; and providing other matters properly relating thereto.

Senator Doñate moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Senator Buck:

Senate Bill No. 295—AN ACT relating to education; requiring the board of trustees of a school district to provide a budget for certain schools to each principal within the district; requiring a public school with more than 500 pupils to list on its Internet website certain information relating to the learning materials that were used for pupil instruction during the immediately preceding school year; and providing other matters properly relating thereto.

Senator Buck moved that the bill be referred to the Committee on Education. Motion carried.

Assembly Bill No. 165 authorizes a claimant who incurs a permanent partial disability on or after July 1, 2017, and whose injury does not exceed 30 percent, to elect to receive his or her compensation in a lump sum.
