INTRODUCTION, FIRST READING AND REFERENCE

By Senators Cannizzaro, Doñate, Dondero Loop and Pazina:

Senate Bill No. 367—AN ACT relating to public safety; prohibiting a person from using, carrying or possessing a firearm under certain circumstances related to the commission of certain drug offenses; prescribing the unit of prosecution for certain crimes involving dangerous weapons;

authorizing a juvenile justice agency, the juvenile court and an agency which provides child welfare services to release certain information and records for the purpose of conducting a background check relating to the sale or transfer of a firearm; providing a penalty; and providing other matters properly relating thereto.

Senator Cannizzaro moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Senators Harris, Spearman, Doñate, Neal, Cannizzaro, Daly, Dondero Loop, Flores, Lange, Nguyen, Pazina and Scheible:

Senate Bill No. 368—AN ACT relating to real property; authorizing certain persons to file a petition requesting that certain restrictions or prohibitions be redacted from an original written instrument relating to real property; requiring the county recorder to redact certain restrictions or prohibitions from an original written instrument under certain circumstances; eliminating certain provisions relating to a declaration of removal of a discriminatory restriction or prohibition; requiring each county recorder in this State to provide certain notice to each owner who recorded a declaration of removal of a discriminatory restriction or prohibition with the office of the county recorder; and providing other matters properly relating thereto.

Senator Harris moved that the bill be referred to the Committee on Judiciary. Motion carried.

By Senators Titus, Buck, Goicoechea, Stone, Seevers Gansert, Doñate, Hansen and Krasner; Assemblymen Hansen, Hafen and Koenig:

Senate Bill No. 369—AN ACT relating to taxation; establishing a credit against the modified business tax for taxpayers who donate money to an organization that provides grants to public or private institutions for the establishment of certain programs of residency training and postdoctoral fellowships for physicians; setting forth certain requirements for an organization that provides such grants and for an institution that is a recipient of such a grant; and providing other matters properly relating thereto.

Senator Titus moved that the bill be referred to the Committee on Revenue and Economic Development.

Motion carried.

By Senators Cannizzaro, Nguyen, Doñate, Daly, Harris, Lange, Neal, Pazina and Scheible:

Senate Bill No. 370—AN ACT relating to data privacy; requiring certain entities to develop, maintain and make available on the Internet a policy concerning the privacy of consumer health data; prohibiting such an entity from collecting or sharing consumer health data without the affirmative consent of a consumer in certain circumstances; requiring such an entity to perform certain actions upon the request of a consumer; requiring such an entity to establish a process to appeal the denial of such a request; requiring

such an entity to take certain actions to protect the security of consumer health data; limiting the circumstances under which a processor is authorized to process consumer health data; requiring a processor to assist certain entities in complying with certain requirements; prohibiting a person from selling or offering to sell consumer health data under certain circumstances; prohibiting the implementation of a geofence under certain circumstances; prohibiting discrimination against a consumer for certain reasons; authorizing certain civil actions; providing penalties; and providing other matters properly relating thereto.

Senator Cannizzaro moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By the Committee on Government Affairs:

Senate Bill No. 371—AN ACT relating to local governments; authorizing a board of county commissioners and the governing body of an incorporated city to, with certain exceptions, enact an ordinance or measure relating to affordable housing; and providing other matters properly relating thereto.

Senator Flores moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Senator Doñate:

Senate Bill No. 372—AN ACT relating to health care; prescribing procedures for determining the amount that certain third parties are required to pay to an out-of-network private ambulance service for medically necessary emergency services provided to a covered person; and providing other matters properly relating thereto.

Senator Doñate moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Senators Flores, Doñate, Nguyen and Neal; Assemblymen González, D'Silva and Torres:

Senate Bill No. 373—AN ACT relating to governmental administration; requiring the head of each agency of the Executive Department of the State Government to designate certain information and documents as vital information and documents; requiring the head of each such agency to ensure that such vital information and documents are translated and made available in certain languages; and providing other matters properly relating thereto.

Senator Flores moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Senators Stone, Hansen, Krasner, Buck, Goicoechea and Seevers Gansert and Assemblyman Gurr:

Senate Bill No. 374—AN ACT relating to taxation; exempting from property taxes the primary residence of certain veterans and their surviving spouses; establishing a program to provide partial refunds of property taxes to certain persons who are 55 years of age or older; providing penalties; and providing other matters properly relating thereto.

Senator Stone moved that the bill be referred to the Committee on Revenue and Economic Development.

Motion carried.

By Senators Seevers Gansert and Cannizzaro; Assemblymen Yeager and O'Neill:

Senate Bill No. 375—AN ACT making an appropriation to the Nevada System of Higher Education for a grant program to expand undergraduate and graduate nursing programs at institutions within the System; and providing other matters properly relating thereto.

Senator Seevers Gansert moved that the bill be referred to the Committee on Finance.

Motion carried.

Assembly Bill No. 36.

Senator Lange moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

Assembly Bill No. 43.

Senator Lange moved that the bill be referred to the Committee on Education.
