GENERAL FILE AND THIRD READING

Assembly Bill No. 268.

Bill read third time.

The following amendment was proposed by the Committee on Finance:

Amendment No. 53.

SUMMARY—Makes appropriations for the payment of retention incentives to certain employees of the State Government. (BDR S-1037)

AN ACT making appropriations for the payment of retention incentives to certain employees of the State Government; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. 1. There is hereby appropriated from the State General Fund to the Office of Finance in the Office of the Governor the sum of \$20,970,000 for the payment of retention incentives in accordance with subsection 2 to each person who is an employee in:
 - (a) The Executive Department of the State Government, except:
- (1) Employees of the Nevada System of Higher Education other than the employees of the System in the classified service, as described in subsection 4 of NRS 284.140.
- (2) Persons whose compensation is paid from a budget account that is not subject to NRS 353.150 to 353.246, inclusive, except as otherwise provided in section 3 of this act.
- (3) Persons whose positions are temporary, intermittent or seasonal or are positions for which there is a critical labor shortage pursuant to NRS 286.523.
- (b) The Judicial Department of the State Government, except persons whose positions are temporary, intermittent or seasonal or are positions for which there is a critical labor shortage pursuant to NRS 286.523.
- 2. A retention incentive of \$500 must be paid from the money appropriated by subsection 1 to each person who is eligible for the payment, as described in subsection 1, and who is so employed on:
 - (a) March 31, 2023.
 - (b) June 16, 2023.
- 3. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State General Fund on or before September 15, 2023.
- Sec. 2. 1. There is hereby appropriated from the State General Fund to the Legislative Fund created by NRS 218A.150 the sum of \$325,000 for the payment of retention incentives in accordance with subsection 2 to each person who is an employee in the Legislative Department of the State Government,

except persons whose positions are for a legislative session or are otherwise temporary, intermittent or seasonal.

- 2. A retention incentive of \$500 must be paid from the money appropriated by subsection 1 to each person who is eligible for the payment, as described in subsection 1, and who is so employed on:
 - (a) March 31, 2023.
 - (b) June 16, 2023.
- 3. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State General Fund on or before September 15, 2023.
- Sec. 3. 1. There is hereby appropriated from the State General Fund to the Public Employees' Retirement System the sum of \$81,000 for the payment of retention incentives in accordance with subsection 2 to each person who is an employee of the Public Employees' Retirement System, except persons whose positions are temporary, intermittent or seasonal or are positions for which there is a critical labor shortage pursuant to NRS 286.523.
- 2. A retention incentive of \$500 must be paid from the money appropriated by subsection 1 to each person who is eligible for the payment, as described in subsection 1, and who is so employed on:
 - (a) March 31, 2023.
 - (b) June 16, 2023.
- 3. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State General Fund on or before September 15, 2023.
- Sec. 3.5. 1. There is hereby appropriated from the State General Fund to the Nevada System of Higher Education the sum of \$3,500,000 for the payment of retention incentives for Fiscal Year 2022-2023 to employees of the Nevada System of Higher Education other than the employees of the System in the classified service, as described in subsection 4 of NRS 284.140.
- 2. On or before September 1, 2023, the Nevada System of Higher Education shall submit a report to the Interim Finance Committee regarding the criteria for eligibility and amounts established for the retention incentives required to be paid pursuant to subsection 1 and the number of recipients thereof.

3. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State General Fund on or before September 15, 2023.

Sec. 4. This act becomes effective upon passage and approval.

Senator Dondero Loop moved the adoption of the amendment.

Remarks by Senator Dondero Loop.

Senate Amendment No. 53 amends Assembly Bill No. 268, first reprint, by adding a new section 3.5 appropriating \$3.5 million to the Nevada System of Higher Education (NSHE) to provide for the payment of retention incentives to certain professional staff for Fiscal Year 2023. On or before September 1, 2023, the NSHE shall submit a report to the Interim Finance Committee regarding the criteria for eligibility, the amounts established and the number of recipients for those retention incentives.

Amendment adopted.

Senator Cannizzaro moved that all necessary rules be suspended, that the reprinting of the bill be dispensed with, that the Secretary be authorized to insert Amendment No. 53 adopted by the Senate, and that the bill be placed on the General File and considered next.

Motion carried.

Assembly Bill No. 268.

Bill read third time.

Remarks by Senators Cannizzaro and Seevers Gansert.

SENATOR CANNIZZARO:

Assembly Bill No. 268 in its first reprint and as amended makes General Fund appropriations for the payment of retention incentives of \$500 to employees of the State Government employed on March 31, 2023, and June 16, 2023, as follows: \$20,970,000 to the Governor's Office of Finance for employees of the Executive and Judicial Departments of State Government except persons whose positions are temporary, intermittent or seasonal, or are positions for which there is a critical labor shortage, professional staff of the Nevada System of Higher Education (NSHE) and persons whose compensation is paid from a budget account that is not subject to NRS 353.150 to 353.246, inclusive, unless otherwise provided; \$325,000 to the Legislative Fund for employees of the Legislative Department of State Government, except persons whose positions are for a legislative session or are otherwise temporary, intermittent or seasonal; \$81,000 to the Public Employees' Retirement System for employees of PERS, except persons whose positions are temporary, intermittent or seasonal, or are positions for which there is a critical labor shortage; and \$3.5 million to NSHE for certain professional staff.

On or before September 1, 2023, NSHE shall submit a report to the Interim Finance Committee regarding the criteria for eligibility, the amounts established and the number of recipients for those retention incentives.

I will note that this is the first of what, I believe, will be several steps to allow for this legislative body and the State of Nevada to affirmatively say we believe in the people who work here and serve us as Nevadans, who serve our constituents and who do a fantastic job of ensuring services are delivered to the people who we represent who have sent us here to do the work for them.

Those state employees, for a very long time, have been overlooked. We know this. Anyone who has watched any of the Finance meetings know that we are at a point where it is becoming

very difficult for us as a State to continue to recruit and retain the talent that we know exists out there which allows us to deliver those services. This is across the board: in our state law enforcement, our Health and Human Services Departments, our Department of Motor Vehicles, in this building and our judicial branch.

What you are seeing demonstrated in this bill is a commitment of members of our colleagues across the hall and members of this body. I urge support to say to those employees we do value you; we see you; we want you to come and help us to serve Nevadans. This should, hopefully, be one of the first steps in us to affirmatively say we see you; we know the work you are doing; we know the jobs you are doing are difficult but necessary and helpful to many Nevadans.

We must invest in that workforce. They are our biggest treasure. They are one of the things which keeps this State moving. I am grateful to everyone who serves in this body and makes all of us look exceptional in ways we probably would not on our own, myself included. I urge my colleagues' support.

SENATOR SEEVERS GANSERT:

I, too, support Assembly Bill No. 268. I echo the comments of the Majority Leader. We value our employees, and we recognize that we have fallen behind as far as pay. They worked extremely hard during COVID, and now we have high vacancy rates because of the challenges they faced. We have fallen behind the market level for many of the jobs.

We are grateful that Governor Lombardo proposed this for this year and the next biennium. It will help bridge the gap until we can do more for our public employees. Again, we are grateful for them. I do think this represents our gratefulness. We want to support them and make sure we can hire more folks so those who are working in the trenches will get additional support. I urge support of Assembly Bill No. 268.

Roll call on Assembly Bill No. 268:
