REMARKS FROM THE FLOOR

Senator Hansen requested that his remarks be entered in the Journal.

After talking to Fiscal staff, we are getting an additional \$9\$ billion from the federal government than we normally would have. Unfortunately, one of the bills that died yesterday was Assemblywoman Hansen's bill which was trying to get \$25 million for the school at the Duck Valley Indian Reservation we have talked about, where they have a carcinogenic plume. She has been assured by the chair of the Ways and Means Committee that that effort is still going forward; I know the federal delegation is also working at it. Nine billion dollars is 9,000 million dollars. I hope we make sure as we get near the end of this session, that we come up with the \$25 million we need for that school. We cannot let this slip through the cracks. I want to keep this on everyone's radar; I am not on the Finance Committee. I know especially during the end of session, there is a tremendous push for all those dollars. But I want to make sure this need is not forgotten.

Tomorrow, we should have a delegation from the Duck Valley Indian Reservation here. Hopefully, they will be able to sit with us on the floor. But I also want to make sure you are aware of this need. So, if they come and visit with you, you can assure them we are aware of the carcinogenic plume—which is threatening 500 kids with potential cancer risks—and we will make sure the State carries its fair share, especially in light of the fact we have 9,000 million dollars more than we normally would have. Hopefully, we can give at least \$25 million to help the Indians at that reservation.

By the way, the Reservation is 410 miles from this building. They are going to drive an almost 950-mile roundtrip to come visit us. Please make them feel welcome tomorrow.
