#### REMARKS FROM THE FLOOR

Senator Hansen requested that his remarks be entered in the Journal.

We had a wonderful prayer this morning from the First Church of Christ. I do not know if everyone was aware, but last Thursday was National Prayer Day. So I asked our staff to give me a list of all the different religions that have offered prayers in this building. We had Saint Peter's Episcopal Church, Hilltop Community Church, Bethlehem Lutheran Church, Airport Road Church of Christ, First Christian Church, Temple Sinai, Saint Peter's Episcopal Church, the Catholic Diocese of Las Vegas, Saint Anthony Greek Orthodox Church, Hope Crossing

Community Church, the Bethlehem Lutheran Church, Nevada House of Prayer, the Pax Christian Church, the Bridge Church, the Universal Society of Hinduism, Church of Jesus Christ of Latter-Day Saints and the Reno Hillside Foursquare Church.

The reason I bring it up is in my lifetime, there have often been discussions about organized religion. A common thing that people have said to me is, "I do not need an organized church to tell me how to worship God." I agree completely with that sentiment—I really do—but what I think people overlook is the tremendous amount of good these churches do. They are there to meet the needs of others. You will notice in his prayer this morning he said that.

I am going to focus on one group for a minute. Catholic community services came to my office. I do not know if everybody else had that same opportunity. If you do, I hope you listen to them. Think about this. This is just one religious group in Northern Nevada. They provide, every day, 1,200 meals, seven days a week. They deliver to 10,000 households every month. They have delivered over three million pounds of food. The people who saw me were Nick Klaich, Marie Baxter and a Catholic priest. His name is Chuck Durante, and I know him. I call him Father Chuck because all my kids went to Catholic high schools, and Father Chuck was there. Father Chuck is a different kind of father than I am, but he has been a father figure to thousands of kids in those schools. He was always a constant reminder that there is more to life than eat, drink and be merry.

More importantly regarding Father Chuck are the things we do not see with people like him and all the priests, rabbis and religious leaders that come and share these prayers with us every day is the amount of good they do for people that are struggling in our societies. The number of people that feel lonely and abandoned and are addicted—all sorts of human problems—it is these religious communities and religious leaders who go out of their way to help people that are down and out. Jesus said, "if you have done it to one of the least of these my brothers, you have done it unto me." When we start thinking about organized religion, we sometimes miss the bigger picture.

I will give you one more example. A block from my plumbing shop in Sparks is Saint Vincent's Thrift Store, a former JC Penney outlet store. The largest group in poverty in America today are single women with children. I have been observing the type of folks that go into Saint Vincent's Thrift Store, and a disproportionate share of them are young women with children. When those children go with their moms into these stores that are provided by Catholic charities, the children experience a shopping experience like you would in any other store. What they do not realize though is the Catholics are providing the goods and services in those stores at literally pennies on the dollar. One of the things I found out as well is if people are truly down and out, they will literally give the people the services they need.

The children do not know their mothers are probably staying up at night worrying about how they are going to make their rent payment or how they are going to put food on the table. But when those kids get older, and somebody starts talking about organized religions and whether or not you need them, the child will say, "What you say about that may be true, but the reality is when my mom was struggling years ago, it was the Catholic Church that helped provide her with the fundamentals to help raise me." When you think about that and you multiply those types of experiences for who knows how long, it helps explain why an institutional organization like the Catholic Church has been around for 1,500 years. And why the Lutherans, the rabbis and all the various churches—they provide fundamental services.

For those that may be more skeptical about religion, look at it from a pragmatic standpoint. If the Catholic Church and all these other religions on a smaller scale are doing these sorts of things, in the absence of them, we would have to raise taxation and we would have to force the State to provide the same services these people are providing out of the concepts of love, charity and service. When the State provides it though, it is based out of taxation and compulsion.

So when you see these differences and when these religious leaders come and give our prayers, I have gone out of my way whenever I can to thank them for their prayers, but more importantly, to thank them for the services they provide in our communities, for all those folks that are not as well off as we are and struggle with so many human difficulties. Grief, abandonment, loneliness—it is the Father Chucks of the world that do so much good in our society.

So whenever we can, especially when you hear people bad mouth organized religions, whether we realize it or not, those are fundamental, backbone, foundational things in our society and do so much good behind the scenes. In my heart today, I have a little prayer for all the Father Chucks and Mr. Weiss who gave his prayer today and all those people and these organized religions going

out of their way day after day, week after week without any relief or thanks other than knowing in their hearts they are doing what is the right thing in a theological concept. They are helping take care of the poor and the needy, which is a fundamental concept, as far as I can tell, in every religion, whether it is the Hindus, the Christians, the Jews or whatever it may be.

I want to get that on the record today because I have been thinking a lot about that. I want to say thank you for the people that do so much for those in our societies that have so little. Join me today, have a little prayer in your heart and thank all those religious people. When those people come in here and say a little prayer, if you have a chance to just shake their hand, please thank them for what they do because they do so much behind the scenes that you and I will never experience. Thursday was National Day of Prayer, but in my heart today, I am going to have a little prayer for all those great people that do so much for our societies and for organized religions, whatever they may be in our society, and all the great things they have done for our country.
