We have two items on our agenda today. The first is a work session on <u>Assembly Bill 384</u>. After that, we will open the meeting for public comment. I will open the work session for <u>Assembly Bill 384</u>.

Assembly Bill 384: Revises provisions governing motor vehicles. (BDR 40-725)

Jann Stinnesbeck, Committee Policy Analyst:

As nonpartisan staff, I cannot advocate for or against any measure before this Committee.

Assembly Bill 384 was sponsored by Assemblyman Hafen and heard in this Committee on March 30, 2023. The bill authorizes an automobile wrecker who has acquired a vehicle that is not due to be dismantled, scrapped, processed, or wrecked to authorize the sale of such a vehicle by a consignee at a qualifying consignment auction [Exhibit C].

There was one proposed amendment from Assemblyman Hafen [page 2, <u>Exhibit C</u>]. The amendment:

- Removes all provisions of the bill;
- Authorizes an automobile wrecker to sell certain vehicles that: (1) possess minor damage; and (2) are not due to be salvaged;
- Exempts the automobile wrecker from the requirement to provide the buyer of such vehicles with evidence that they comply with certain engine emission standards for the purpose of registering the vehicles with the Department of Motor Vehicles (DMV); and
- Exempts the automobile wrecker from the requirement to forward to the DMV the certificate of title and registration of such vehicles.

Chair Watts:

[There were none.] I will accept a motion to amend and do pass <u>Assembly Bill 384</u>.
