- **BDR S-1097**—Makes an appropriation to restore the balance of the Stale Claims Account. (Later introduced as <u>Assembly Bill 469</u>.)
- **BDR S-1110**—Makes appropriations to the Office of Finance in the Office of the Governor for certain costs relating to the Enterprise Resource Planning System. (Later introduced as Assembly Bill 468.)
- **BDR S-1127**—Makes an appropriation to the State Public Works Division of the Department of Administration for professional services and filing fees related to water rights associated with the Marlette Lake Water System. (Later introduced as Assembly Bill 470.)
- **BDR S-1136**—Makes an appropriation to the State Public Works Division of the Department of Administration for replacement of computer hardware and associated software. (Later introduced as Assembly Bill 471.)
- **BDR S-1137**—Makes an appropriation to the Purchasing Division of the Department of Administration for the purchase of a warehouse building in Las Vegas, Nevada, to replace leased space. (Later introduced as <u>Assembly Bill 472</u>.)
- **BDR S-1138**—Makes an appropriation to the Fleet Services Division of the Department of Administration for the replacement and purchase of vehicles. (Later introduced as <u>Assembly Bill 473</u>.)
- **BDR S-1139**—Makes an appropriation to and authorizes the expenditure of money by the Commission on Ethics for the replacement of computer hardware and associated software. (Later introduced as <u>Assembly Bill 474.</u>)
- **BDR S-1148**—Make appropriations to the Department of Administration for certain activities and technology requirements of the National Judicial College and the National Council of Juvenile and Family Court Judges. (Later introduced as <u>Assembly Bill 475</u>.)
- **BDR S-1150**—Makes an appropriation to the Knowledge Account. (Later introduced as <u>Assembly Bill 467</u>.)
