#### **Chair Monroe-Moreno:**

[Roll was called, and the Committee rules and protocols were explained.] We are meeting to hear a number of bill draft request (BDR) introductions. Your vote in the affirmative is not saying you support the measure once it becomes a bill, it just moves us along in the process. With that, I will turn this over to Ms. Coffman to present the BDRs.

## Sarah Coffman, Assembly Fiscal Analyst:

[Ms. Coffman presented the following bill draft requests:]

- **BDR S-1140**—Makes appropriations to and authorizes the expenditure of money by the Office of Economic Development in the Office of the Governor for the replacement of computer hardware and associated software and the costs of office furniture, communication services, certain staff certification and office modification. (Later introduced as <u>Assembly Bill 504.</u>)
- **BDR S-1143**—Makes appropriations to and authorizes the expenditure of money by the Department of Veterans Services and the Veterans Home Account for the replacement of computer hardware and associated software, the purchase of information technology peripheral devices and the performance of certain projects. (Later introduced as Assembly Bill 505.)
- **BDR S-1147**—Makes appropriations to the Division of Enterprise Information Technology Services of the Department of Administration for the replacement of an information technology investments tracking system and computer hardware and associated software. (Later introduced as <u>Assembly Bill 506</u>.)
- **BDR S-1157**—Makes appropriations to the Department of Corrections for a staffing study and the replacement or purchase of computer hardware and software and various types of equipment, vehicles and systems. (Later introduced as <u>Assembly Bill 507</u>.)
- **BDR S-1164**—Makes appropriations to the Division of Parole and Probation of the Department of Public Safety for the replacement of computer hardware and associated software, radio equipment, certain weapons and an information technology system. (Later introduced as <u>Assembly Bill 508</u>.)
- **BDR S-1165**—Makes appropriations to the Investigation Division of the Department of Public Safety for the replacement of vehicles, radio equipment, cameras, computer hardware and associated software and certain weapons. (Later introduced as <u>Assembly Bill 509</u>.)

- **BDR S-1176**—Makes appropriations to the Department of Motor Vehicles for the replacement or purchase of computer hardware and software, office furniture and equipment. (Later introduced as <u>Assembly Bill 510</u>.)
- **BDR S-1184**—Makes appropriations to the Division of Public and Behavioral Health of the Department of Health and Human Services for the replacement of computer hardware and associated software, the replacement of office furniture and equipment and deferred maintenance projects. (Later introduced as <u>Assembly Bill 511.</u>)
- **BDR S-1185**—Makes appropriations to and authorizes the expenditure of money by the Division of Welfare and Supportive Services of the Department of Health and Human Services for certain information technology upgrades and projects. (Later introduced as Assembly Bill 512.)
